## Terms

### Agreement Of Services

This release includes claims arising from negligence, errors, omissions, misconduct, or unforeseen circumstances. I understand and agree that this waiver is a binding legal agreement, entered into voluntarily, and applies to the fullest extent permitted by law.

### Registered Owner

I certify that I am the registered owner or have obtained the full authority from the registered owner(s) of the vehicle being submitted to King and Queen Mobile Detailing LLC for services. By providing this certification, I acknowledge that I am responsible for ensuring that all necessary permissions are in place, and I accept full liability in the event that any issues arise from unauthorized submissions. King and Queen Mobile Detailing LLC shall not be held liable for any claims, damages, or disputes that result from a lack of proper authorization regarding the

vehicle. This certification serves as a binding agreement that I will indemnify and hold harmless King and Queen Mobile Detailing LLC from any legal consequences related to the ownership of the vehicle.

### **Stains and Paint Defects**

While Queen Mobile Detailing LLC will make every effort to remove stains and defects from your vehicle's interior and exterior, we cannot guarantee the complete removal of all contaminants. This includes, but is not limited to, irremovable carpet or seat stains, irreversible paint defects, and other similar issues that may be present prior to our services. It is important to acknowledge that some stains may be permanent or may require specialized treatment beyond our standard offerings. By proceeding with our services, you accept the possibility that certain imperfections may remain despite our best efforts.

### **Child Seats / Booster Seats**

Both parties acknowledge that Queen Mobile Detailing LLC will not be responsible for the removal or installation of child car seats and/or booster seats during the detailing service. Clients are required to ensure that all such items are removed from their vehicles prior to the scheduled service appointment. This policy is in place to ensure the safety of children and to allow for thorough cleaning of the vehicle interior. Failure to comply may result in limitations on the services provided.

### **Personal Belongings**

I acknowledge that all personal belongings and property left in the vehicle prior to detailing services are my sole responsibility. King & Queen Mobile Detailing LLC will not be liable for any loss, theft, or damage to such items during service. It is the client's responsibility to remove all personal items from the vehicle before services begin. By agreeing to these terms, I release King & Queen Mobile Detailing LLC from any claims, disputes, or liabilities related to personal belongings left in the vehicle.

### **Property Access, Permission, and Liability Disclaimer**

By scheduling mobile detailing services, the client grants King & Queen Mobile Detailing LLC permission to access the service location, including driveways, garages, parking areas, and other necessary spaces, for the purpose of performing the agreed-upon work. This includes, but is not limited to, damage from water runoff, cleaning chemicals, equipment, or accidental contact with landscaping, structures, or other property. The client assumes full responsibility for securing pets, children, and personal property during the service.
